

## Kymsol privacy policy

Kymsol is committed to protecting the privacy of the users of our [kymsol.com](http://kymsol.com) website ("Site") according to the Personal Data Act (523/1999), the Act on the Protection of Privacy in Electronic Communications (516/2004) and other applicable laws.

The purpose of this privacy policy is to inform the user of the site what type of data we collect, how we use that data and how we transfer this data to third parties. In this privacy policy we also describe the cookies policy on our Site and on third party websites. By using the Site you agree to the processing of your personal information according to this privacy policy.

### Collected data and regular data sources

We may collect personal information from the user him/herself when visiting the Site by using cookies and other techniques, among others. We may collect data on e.g. how the user uses the Site and our other services.

The personal information collected on users when using the Site include necessary information with regard to the purpose of processing personal information. We may collect e.g. contact information such as name, phone number, e-mail address and other possible information collected with the user's consent.

### The purpose of processing personal information

We use personal/user information collected via the Site for the following purposes e.g.:

- Analytics and statistics on the Site
- Communications regarding our Site and services, maintaining customer relationships;
- Producing, providing, developing, enhancing and protecting our services and the Site;
- Preventing and investigating abuse;
- Protecting rights and/or property related to the Site; and
- Other similar purposes

### Cookies policy

Cookies are usually small text files that your internet browser saves on your terminal to identify and re-identify the user. The text file contains a small piece of information that the internet server may read at the next visit to the same page. Some of these cookies are essential for browsing websites. Other cookies are useful from the user's point of view because they ease using the site by e.g. remembering your user name or the chosen language settings. With the help of cookies we can identify your browser and use the information acquired for counting the browsers visiting the site, and analysing their use of our site, i.e. statistical monitoring. Our goal is to develop our service in this way to make it serve users even better.

### Cookies used on the Site

Cookies may be used to collect the following information:

- User's IP-address;
- Time;
- Websites used and the time spent on them
- Browser type, terminal operating system;
- The web address from which the user accessed the Site and where he/she moves to after using the Site; and
- The server and domain from which the user accessed the Site

The Site may also contain cookies of third parties such as measuring and tracking services. Third parties may place cookies on your terminal when you visit our Site.

You may control to what extent you accept the use of cookies and targeting marketing, if you so wish. You can prevent the use of cookies by changing your browser settings. Please note that should you delete the cookies, you may not be able to use certain functions on the Site.

## Regular transferal of information

Information collected via automatic data collection may be disclosed to the following categories of persons:

- Service providers such as companies specialized in data analysis and internet marketing
- The Authorities in those cases where the law or our benefit or the benefit of a third party requires it
- Our affiliates and associated companies or other companies that are part of the same group or economic corporation, a new owner, partial owner or operator of the Site and their advisers in the case of company acquisition or transaction.
- In addition, information may be transferred to third parties in a form in which individual users cannot be identified and it is not personal information.

## Transferring data outside the EU or EEA

Due to the technical implementation of processing data, some Site information may be physically located on servers outside the European Union. Data transfer is based on the user's consent.

## Links to third party sites

Our Site may contain links to web pages hosted by third parties. We are not liable for such third party site content or privacy policies. We recommend that you carefully go through the terms concerning the privacy policy of each site.

## Principles of protecting personal information

We use the necessary technical and organisational data protection measures to protect personal information from unauthorized access and their accidental or illegal deletion; changing, transferring, giving away or any other illegal method of processing them.
